Official Rules

THESE OFFICIAL RULES GOVERN ALL ASPECTS OF PARTICIPATION AND PRIZES.

- 1. **Introduction**: One (1) winner will be selected in a random drawing from among all qualified entries to win a Sakrete swag kit containing ten hats, ten pairs of gloves, ten koozies, and ten belt buckles which has a value of \$250 ("Sweepstakes"). Federal, state, provincial, municipal, territorial and local laws and regulations apply.
- 2. **Sponsor:** The sponsor of the Sweepstakes is Oldcastle APG, Inc. ("Sponsor").
- 3. **Prize and Approximate Retail Value:** One (1) prize will be awarded in this Sweepstakes. The approximate retail value of the prize is \$250. The prize consists of ten hats, ten pairs of gloves, ten koozies, and ten belt buckles ("Prize"). All fees, federal, state and other taxes, costs and expenses relating to the use, acceptance and possession of the Prize are the sole responsibility of the winner.
- 4. **Right to Substitute:** Sponsor has the right to substitute the Prize with another prize of equal or greater value if the advertised Prize is not available.
- 5. **Agreement to Official Rules**: By entering, you indicate your full and unconditional agreement to (a) these Official Rules and (b) Sponsor's decisions, which are final and binding. Winning the Prize is contingent upon fulfilling all requirements set forth herein. Entry constitutes permission (except where prohibited by law) to use the winner's name for purposes of advertising, promotion and publicity without compensation.
- 6. **Entry Period**: The Sweepstakes begin on June 21, 2024 at 12:00 a.m. Eastern Time ("ET") and end on June 30, 2024 at 11:59 p.m. ET ("Promotion Period"). Sponsor's computer is the official time-keeping device for the Sweepstakes.
- 7. **How to Enter**: During the Promotion Period, follow our Instagram page (@sakrete), like the giveaway post, comment, and tag three friends in the comments on the post. Once all of these tasks are completed, you are automatically entered in the Sweepstakes. Limit of one (1) entry per person. Sponsor may require potential winner to show proof of being the authorized account holder.
- 8. **Eligibility**: The Sweepstakes is open to those who are, as of the beginning of the Promotion Period, legal residents of the fifty (50) United States (and the District of Columbia) and at least eighteen (18) years of age or older. Void where prohibited or restricted by law.
- 9. Drawing, Odds and Notification: On or about July 1, 2024, Sponsor will randomly select a



potential winner from among all eligible entries received. Odds of winning the Prize depend on the number of eligible entries received. The potential winner will be notified through Instagram and must respond to accept or decline the Prize within seven (7) days of notification. If a potential winner cannot be contacted or does not timely respond, or if the Prize or Prize notification is undeliverable, an alternate potential winner will be selected. Upon Prize forfeiture, no payment or other compensation will be made to the original potential winner. In the event of non-compliance with this or any other requirement, the non-complying potential winner will be disqualified.

- 10. Right to Cancel or Modify: Sponsor reserves the right, in its sole discretion, to terminate, modify or suspend the Sweepstakes if, in Sponsor's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if viruses, bugs, unauthorized intervention, fraud, technical difficulties or failures or any other factor beyond Sponsor's reasonable control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes. In such event, Sponsor reserves the right (but does not have the obligation) in its sole discretion to award the Prize at random from among eligible, non-suspect entries received up to the time of suspected impairment. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws, and, should such an attempt be made, Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules is not a waiver of that provision or any other provision of these Official Rules.
- 11. **Limitation of Liability:** Sponsor is not responsible and cannot be held liable for technical errors or other things that may prevent the Sweepstakes from running as planned.
- 12. **Release:** Entrants agree to release and hold the Sponsor harmless from and against any claim associated with the Sweepstakes.
- 13. **Release of Instagram:** Each entrant releases Instagram from any liability related to the Sweepstakes.
